## Who Can Enter:

- 5. Must be eligible for entrance to New Zealand and Australia.
- 6. Must be available for the travel period November 10, 2018 November 24, 2018.
- Must be available to travel to and from one of the following the airports: Brisbane, Sydney, Melbourne, Adelaide, Canberra, Australia, or Auckland, Wellington, Christchurch, Queenstown, New Zealand, or Vancouver, Canada, or Los Angeles, San Francisco, United States.
- 8. Must have valid Travel & Health Insurance, must include bike coverage.
- 9. The Contest is subject to all federal, provincial, and municipal laws, and is void where prohibited.
- 10. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

## Timing:

- 11. The Contest is open from February 7th, 2018 at 12:01AM Pacific Standard Time ("PST") to February 28th, 2018 at 12:00 PM PST (the "Contest Period").
- 12. Winner to reply within 48 hours
- 13. How To Enter:
  - a. Entrants may visit <a href="https://www.pinkbike.com/">https://www.pinkbike.com/</a> (the "Site") during the Contest Period.
  - b. To participate in the Contest the entrant must be logged into Pinkbike via their own Pinkbike account. It is free to sign up for a Pinkbike account: https://www.pinkbike.com/user/signup/

- 14. To enter the Prize Draw Contest the entrant must click on entry button (CLICK HERE TO ENTER) found on the Contest Post. The entrants Pinkbike username will be automatically entered to win eligible prizing.
- 15. Any use of an electronic device to enhance or alter entrants' odds of winning will count as a fraudulent entry. Entries that are fraudulent are not permitted and will be declared invalid.
- 16. All entries become the property of the Sponsor and will not be acknowledged or returned. Receipt of entries for the Contest will not be acknowledged, and proof of submission of an entry will not be deemed proof of receipt.
- 17. The Sponsor reserves the right to delete any entries or remove participants that are in violation of the Official Rules.
- 18. By participating in the Contest, entrants agree to be bound by these Official Rules.

## Grand Prize:

- 19. Travel for 14 nights, includes 8 days mountain biking, lift tickets for all participating bike parks, return flights for two people provided, 12 nights of accommodation for travel period, transportation between stops.
- 20. Winners will be notified via the email associated with their Pinkbike account or via their Pinkbike account within 48 hours of their name being drawn.
- 21. In order to be verified the as the Winner, the selected entrant must respond to the prize notification email or Pinkbike message within ten (10) days of transmission, confirming that he/she:
  - a. (i) has read, understands and complies with the Official Rules;
  - b. (ii) releases and discharges the Sponsor; and
  - c. (iii) consents to the announcement of the Winner's name and the use by or on behalf of the Sponsor of the Winner's name and/or photograph and/or video for advertising and promotional purposes, without any further compensation to the Winner.

- 22. Should the Winner fail to comply with any of the requirements contained in these Official Rules, the Grand Prize will be automatically forfeited and the Finalist with the next highest amount of votes will be selected and the initial Winner will be disqualified and will have no recourse towards the Sponsor or anyone involved in the Contest.

  - a. any erroneous lost, damaged, late, incomplete, misdirected, deleted, defective, or altered Contest registrations, regardless of the cause, including, but not limited to, failure of the Site;
  - b. any failure for any reason whatsoever of the selected entrant to receive a prize notification;
  - c. any changes in email addresses after Contest registrations are submitted; and
  - d. any computer, online, telephone, or technical malfunctions or errors that may occur, regardless of the cause.

The Sponsors will be responsible for flights to nearest airport and extra airline baggage fees for eligible bike transport and destination airport pickup and 1 nights accommodation on day of arrival. Winner is responsible for getting transport to/from departure airport, and any extra duties, taxes and fees including applicable insurance required for travel (including bike coverage).
- 29. Decisions of the Sponsors are final and binding.
- 30. By entering the Contest, participants consent to the Sponsor's collection, use, and disclosure of the personal information provided in the Contest registration for the administration of the Contest, including posting of the Winner's name and city of residence on the Sponsor's website. The Sponsor will use the Winner's personal information only for identified purposes, and protect the Winner's personal information in a manner that is. Entrants may write to the Sponsor and request that their information be removed from the Sponsor's records.
