

## 2020 Pinkbike EWS Fantasy League & Trivia - Fantasy EWS Presented by Shimano

### OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

#### 1. ENTRY PERIOD & CONTEST SPONSORS:

- a. Pinkbike Fantasy EWS League & Trivia (the "Contest Game") is sponsored by Pinkbike, located at 1-37749 2 Avenue, Squamish, BC V8B0S8, Canada (the "Sponsor").
- b. Sponsor partners of the contest includes: Shimano
- c. There are prizes to be awarded per each round of the Trivia round or the Enduro World Series starting June, 2020 and a Grand Prize to be awarded at the conclusion of the 2020 season. Number of and actual prizes for the contest will be determined by the sponsor and sponsor partners of the contest. Chances of winning depend on the total number of participants who have entered to play the Contest Game.
- d. Due to the current global coronavirus pandemic, a combination of the Fantasy League & Trivia will occur. Trivia will replace race rounds that have postponed/cancelled and roll over to League once EWS Racing resumes for the season. In the event that no races occur during the 2020 season, the full Fantasy League will be replaced by Trivia.
- e. The Contest will begin with Trivia June 2020 and will end by no later than 31 December 2020. Each Contest Period will be posted in either the League or Trivia published articles. Terms will be updated to reflect changes based on revised dates of the regular EWS series, (the "Contest Game Period").

#### 2. WHO CAN ENTER:

- a. The Contest Game is open worldwide.
- b. The Contest Game is subject to all federal, provincial, and municipal laws, and is void where prohibited.
- c. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Contest Game. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- d. Pinkbike, Shimano and their family members, and those living in the same household are able to participate in the league/trivia but are not eligible to win any prizing.
- e. Sponsored Athletes, Brand Ambassadors and Influencers with partnerships with MTB Brands are able to participate in the league but are not eligible to win any prizing.

#### 3. HOW TO ENTER AND PARTICIPATION:

- a. Entrants must visit <https://www.pinkbike.com/> (the "Site") during the Contest Game Period.
  - i. To participate in the Contest Game the entrant must be logged into Pinkbike via their own Pinkbike account. It is free to sign up for a Pinkbike account: <https://www.pinkbike.com/user/signup/>
  - ii. All contest entries agree to abide by the Terms of Use of Pinkbike - <http://www.pinkbike.com/about/legal/#terms-of-use>
  - iii. Registration for the Contest Game is free.
  - iv. The entrant must visit the contest page during the ("Contest Period") and follow the instructions including How To Play can be found on <https://www.pinkbike.com/contest/fantasy/> and Play Trivia and/or Create EWS Team and play the ("Contest Game"). Which one will be determined by the current situation of race rounds being held.
- b. ("The Contest Game") is based on the Enduro World Race Series. The series are made up of 7 Enduro World Series Races and 1 Trophy of nations Race, for each postponed/cancelled race this will be a Trivia round. In the event that Race Rounds are not held during the 2020 season the Trivia will replace the League in its entirety.
- c. For each Trivia round will feature 15 questions and the first one will run 10 days. The Contest Period for each Trivia will be posted within the Article. Points will be awarded as per Trivia Round Scoring in "Exhibit A".
- d. For each EWS race round your Fantasy Team will accrue points based upon your athletes final placing. Points will be awarded as per "Race Round Scoring" in "Exhibit B")
- e. Once racing resumes we'll continue with the regular Fantasy EWS League and combine the points from Fantasy Trivia with Fantasy EWS. Points will be combined from both Trivia and League to determine the Overall winner with highest number of points
- f. Any use of an electronic device to enhance or alter entrants' odds of winning will count as a fraudulent entry. Entries that are fraudulent are not permitted and will be declared invalid.
- g. All entries become the property of the Sponsor and will not be acknowledged or returned. Receipt of entries for the Contest will not be acknowledged, and proof of submission of an entry will not be deemed proof of receipt.
- h. The Sponsor reserves the right to delete any entries or remove participants that are in violation of the Official Rules.
- i. By participating in the Contest, entrants agree to be bound by these Official Rules.

4. PRIZING:

- a. Grand Prize: Top Team (highest number of points) Overall combined Fantasy Trivia and Fantasy League at the end the Contest Period will win all-new Ibis Ripmo V2 complete with the new 12 speed Shimano XT M8100 groupo including the new XT asymmetrical 30mm wide rims, Fox Suspension, PRO Components featuring the all-new 3FIVE cockpit and a 170mm Koryak dropper post. In the event of a tie (multiple entrants with the same total number of points), the top overall teams will be drawn at random to determine the overall winner.
- b. Race Round Prizing: Top 4 Users/Teams (highest number of points) Overall for Each Trivia or Race during the Enduro World Series and EWS Trophy Of Nations will win a prize from the Sponsor. In the event of a tie (multiple entrants with the same total number of points) the winner will be drawn at random from the top overall scores.
- c. Winners will be notified via email address registered with their Pinkbike User Account within 7 days of the winner being determined.
  - i. In order to be verified the as the Winner, the selected entrant must respond to the prize notification email or Pinkbike message within seven (7) days of transmission, confirming that he/she:
  - ii. has read, understands and complies with the Official Rules;
  - iii. releases and discharges the Sponsor; and
  - iv. consents to the announcement of the Winner's name and the use by or on behalf of the Sponsor of the Winner's name and/or photograph and/or video for advertising and promotional purposes, without any further compensation to the Winner.
- d. Should the Winner fail to comply with any of the requirements contained in these Official Rules, the Prize will be automatically forfeited and the Winner will be redrawn and the initial Winner will be disqualified and will have no recourse towards the Sponsor or anyone involved in the Contest Game.
- e. The prizes shown may vary from those advertised. Sponsors will have sole discretion over prizes, if a prize is no longer available and a substitute will be decided and provided by the sponsor.
- f. The prizes must be accepted as awarded. No cash alternatives, substitution or transfers of the prizes will be allowed.
- g. The grand prize may not be sold without explicit consent from Shimano within 365 days of receiving the prize.
- h. Winners are responsible for taxes, duty and/or import tariffs, where applicable.

5. OTHER MATTERS:

- a. The Contest Game is subject to all applicable federal, provincial and local/municipal laws and is void where prohibited by law. If any provision of these Official Rules is found by any court of competent jurisdiction to be unenforceable, all other provisions will remain in full force and effect.
- b. The Sponsor will not, under any circumstances, be responsible for, or liable to any entrant or any other person for:
  - i. any erroneous lost, damaged, late, incomplete, misdirected, deleted, defective, or altered Contest registrations, regardless of the cause, including, but not limited to, failure of the Site;
  - ii. any failure for any reason whatsoever of the selected entrant to receive a prize notification;
  - iii. any changes in email addresses after Contest registrations are submitted; and
  - iv. any computer, online, telephone, or technical malfunctions or errors that may occur, regardless of the cause.
- c. If for any reason the Contest Game is not capable of being conducted as intended by the Sponsor, including due to computer viruses, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other cause that corrupts or interferes with the administration, security, fairness, integrity or proper conduct of the Contest, the Sponsor may, at its sole discretion, disqualify any entrant responsible for such misconduct and cancel, terminate, modify, or suspend the Contest Game.
- d. The Sponsors will ship the prizing direct. The Sponsor will not be responsible for any tax or customs liability that arises in relation to the delivery of the prizing.
- e. Decisions of the Sponsors are final and binding.
- f. If a contestant makes any false statement, (s)he will be automatically disqualified from the Contest.
- g. By entering the Contest Game, participants consent to the Sponsor's collection, use, and disclosure of the personal information provided in the Contest Game registration for the administration of the Contest, including posting of the Winner's name and city of residence on the Sponsor's website. The Sponsor will use the Winner's personal information only for identified purposes, and protect the Winner's personal information in a manner that is. Entrants may write to the Sponsor and request that their information be removed from the Sponsor's records.

15 Multiple Questions will be provided in the published Trivia article. Users will be awarded points based on correct answers. Each question answered correctly will be worth 50 points for a total of 750 points available for each Trivia round.
