1. Who can play?

By entering a video, the entrant certifies the video is one’s original edit of the provided content, and the content does not infringe on any 3rd party’s rights. No mail-in entries will be allowed and any use of automatic programming to submit entries will be void. Finally, please make sure to adhere to the following criteria:

Submission Guidelines:

- Film MTB themed footage must be 100% on GoPro camera.
- All edits can be no longer than 1 minute long (including the contest video bumper graphic)
- All edits must exclusively use the audio provided for the contest as found on the contest page <https://www.pinkbike.com/contest/gopro> under the DOWNLOAD ASSETS button
- The GoPro Evolution Bumper must be included at the end of your edit
- You have to accept the terms and conditions of the contest(s).
- You may use any post production treatments, overlay graphics or special effects as you desire in your final edit.
- Videos must be in MP4 format in HD or Higher Resolution (720p, 1080p, 1440, 2.5k, 4k) with no watermarks

Submission Restrictions

5. How will I find out if I win?

GoPro will send the good news by direct message on the platform the contestant entered through. After this, GoPro may require the winner to sign an "Affidavit of Eligibility and Liability/Publicity Release" within ten (10) days of date of receipt.

We promise to do our best to locate and communicate with you if you are the winner. If we cannot confirm your identity within three months or any other disputes arise, we will contact the next best entry.
