

ROTOR America “Get Lucky With ROTOR 1x13” giveaway: Terms & Conditions 2019

OFFICIAL RULES NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

There are prizes to be awarded in November 2019. Number of and actual prizes for the contest will be determined by the sponsor and sponsor partners of the contest. Chances of winning depend on the total number of eligible entries received.

Who Can Enter:

1. The Contest is only open to people living in the USA at the time of the contest.
2. Winner must be 18 years or older on November 1st, 2019.
3. The Contest is subject to all federal, provincial, and municipal laws, and is void where prohibited.
4. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
5. The Contest is open on the 26th of September at 12:00 AM Pacific Standard Time (“PST”) to 25 October, 2019 at 12:00 PM PST (the “Contest Period”).
6. It is the sole responsibility of the winner to verify the requirements and eligibility.
7. How To Enter:
 - a. Entrants may visit <https://www.pinkbike.com/> (the “Site”) during the Contest Period.
 - b. To participate in the Contest the entrant must be logged in to Pinkbike via their own Pinkbike account. It is free to sign up for a Pinkbike account: <https://www.pinkbike.com/user/signup/>
 - c. All contest entries agree to abide by the Terms of Use of Pinkbike - <http://www.pinkbike.com/about/legal/#terms-of-use>
 - d. Registration for the Contest is free.
8. To enter the Prize Draw Contest the entrant must click on entry button found on the contest post/contest page. The entrant's Pinkbike username will be automatically entered to win eligible prizing.
9. Any use of an electronic device to enhance or alter entrants’ odds of winning will count as a fraudulent entry. Entries that are fraudulent are not permitted and will be declared invalid.
10. All entries become the property of the Sponsor and will not be acknowledged or returned. Receipt of entries for the Contest will not be acknowledged, and proof of submission of an entry will not be deemed proof of receipt.
11. The Sponsor reserves the right to delete any entries or remove participants that are in violation of the Official Rules.
12. By participating in the Contest, entrants agree to be bound by these Official Rules.

13. At the end of the Contest Period names will be drawn at random to determine winners of the prize(s).
14. Winners will be notified via their email address associated with their Pinkbike account within 48 hours of their name being drawn.
15. In order to be verified the as the Winner, the selected entrant must respond to the prize notification email or Pinkbike message within seven (7) days of transmission, confirming that he/she:
 - a. Has read, understands and complies with the Official Rules;
 - b. Releases and discharges the Sponsor;
 - c. Consents to the announcement of the Winner's name and the use by or on behalf of the Sponsor of the Winner's name and/or photograph and/or video for advertising and promotional purposes, without any further compensation to the Winner.

Should the Winner fail to comply with any of the requirements contained in these Official Rules, the Prize will be automatically forfeited and the Finalist with the next highest amount of votes will be selected and the initial Winner will be disqualified and will have no recourse towards the Sponsor or anyone involved in the Contest.

 - a. Any erroneous lost, damaged, late, incomplete, misdirected, deleted, defective, or altered Contest registrations, regardless of the cause, including, but not limited to, failure of the Site;
 - b. Any failure for any reason whatsoever of the selected entrant to receive a prize notification;
 - c. Any changes in email addresses after Contest registrations are submitted; and
 - d. Any computer, online, telephone, or technical malfunctions or errors that may occur, regardless of the cause.

If for any reason the Contest is not capable of being conducted as intended by the Sponsor, including due to computer viruses, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other cause that corrupts or interferes with the administration, security, fairness, integrity or proper conduct of the Contest, the Sponsor may, at its sole discretion, disqualify any entrant responsible for such misconduct and cancel, terminate, modify, or suspend the Contest.
22. The Sponsors will ship the prize direct. The Sponsor will not be responsible for any tax or customs liability that arises in relation to the delivery of the prize.
