# 2018 Moment Ride BC Giveaway

OFFICIAL RULES

There are 5 prizes to be awarded between March 15, 2018 and March 29, 2018. Number of and actual prizes for the contest will be 5 determined by the sponsor and sponsor partners of the contest. Chances of winning depend on the total number of eligible entries received.

### Who Can Enter:

# Timing:

- 4. The Contest is open from 15th March 2018 at 9:00 AM Pacific Standard Time ("PST") to 29 March 2018 at 12:00 PM PST (the "Contest Period").

  - b. To participate in the Contest the entrant must be logged into Pinkbike via their own Pinkbike account. It is free to sign up for a Pinkbike account: https://www.pinkbike.com/user/signup/
  - c. All contest entries agree to abide by the Terms of Use of Pinkbike http://www.pinkbike.com/about/legal/#terms-of-use
  - d. Registration for the Contest is free.

  on the Contest Post. The entrants Pinkbike username will be automatically entered to win eligible prizing.
  The entrant also acknowledges that they submit their current email address.
- 7. Any use of an electronic device to enhance or alter entrants' odds of winning will count as a fraudulent entry. Entries that are fraudulent are not permitted and will be declared invalid.
- All entries become the property of the Sponsor and will not be acknowledged or returned. Receipt of entries

- 9. The Sponsor reserves the right to delete any entries or remove participants that are in violation of the Official Rules.

# Grand Prize:

- 11. At the end of the Contest Period names will be drawn at random to determine winners of the 5 prizes.
- 12. Winners will be notified via email provided within 48 hours of their name being drawn
- 13. In order to be verified the as the Winner, the selected entrant must respond to the prize notification email or Pinkbike message within seven (7) days of transmission, confirming that he/she:

- a. (i) has read, understands and complies with the Official Rules;
- b. (ii) releases and discharges the Sponsor; and
- c. (iii) consents to the announcement of the Winner's name and the use by or on behalf of the Sponsor of the Winner's name and/or photograph and/or video for advertising and promotional purposes, without any further compensation to the Winner.

  - a. any erroneous lost, damaged, late, incomplete, misdirected, deleted, defective, or altered Contest registrations, regardless of the cause, including, but not limited to, failure of the Site;
  - b. any failure for any reason whatsoever of the selected entrant to receive a prize notification;
